MAILING INSTRUCTIONS

- To *ensure timely delivery*, ballots returned by US Mail **must be Post Marked** by Saturday, July 26, 2008 within the pick-up hours posted at your post office.
- 42 cents FIRST CLASS POSTAGE stamp required.
- **TWO ENVELOPES** are required to maintain confidentiality & for mailing
- Complete your Ballot as desired and seal in an unmarked envelope.
- Using the 2nd envelope print your name & return address in the appropriate spot.
- Address the 2nd envelope to:

- Place the envelope with your BALLOT inside the FAMUFF addressed envelope.
- Seal the FAMUFF envelope & sign across the back seal to ensure confidentiality.
- **STAMP & mail by July 26th to ensure delivery by the July 29th Ballot Count.**

If mailing your ballot from outside Leon, Gadsden, Jefferson, Wakulla or Liberty County, consult the US Post Office for the time frame and postage required for timely delivery.
